**GRAYSON COUNTY WATER DISTRICT'S RESPONSE TO
COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION**

QUESTION 1.

Refer to Grayson District's Responses to Commission Staff's First Request for Information (Staff's First Request), Items 5–6. The responses were unresponsive.

a. Provide all historical meter test records for Grayson District's water meter, Meter/ID Number 236114078, Device # 81636757, Model .63" 7D 10M, with an installation date of July 20, 2017, as required by 807 KAR 5:006, Section 18, that appears to have been inadvertently omitted from Grayson District's Response to Staff's First Request for Information, Item 5.

b. Provide each monthly water utility bill for 118 Wilson Lane, Leitchfield, Kentucky 42754 from June 2025 through April 2026, that appears to have been inadvertently omitted from Grayson District's Response to Staff's First Request for Information, Item 6.

ANSWER 1.

- a. See attached meter test results.
- b. See attached monthly water bills.

QUESTION 2.

Provide each monthly water utility bill for 118 Wilson Lane, Leitchfield, Kentucky 42754 from June of 2023 through June of 2025.

ANSWER 2.

See attached monthly water bills.

QUESTION 3.

Referring to Grayson District's Responses to Staff's First Request, Items 3–4. When Grayson District stated that the meter at 118 Wilson Lane was read monthly, explain whether the monthly reading was an in-person, visual reading of the water meter at 118 Wilson Lane or whether the monthly reading was looking at the data the encoder-receiver-transmitter (ERT) transmitted each month for the water meter at 118 Wilson Lane for the period of June 2023 through June 2025.

ANSWER 3.

The monthly reading was from the data that the ERT transmitted each month for the meter at 118 Wilson Lane for the period of June 2023 to June 2025. The only in-person visual reading took place in June 2025 when the leak and high usage were discovered.

QUESTION 4.

Explain whether Grayson District regularly checks its ERTs for malfunctions or performs routine maintenance on its ERTs. If yes, explain how often the ERTs are checked for malfunctions, the process for regularly checking ERT functionality, and how often maintenance is performed on the ERTs.

ANSWER 4.

Grayson County Water District regularly checks its ERTs for malfunctions and performs routine maintenance on its ERTs. The reading software the District uses for meter reading has a built-in warning system that alerts the District to ERTs that may have issues. Meter readers receive those warnings while reading the meters monthly. The warnings can indicate if an ERT has been detached, if usage is high or low, if there is no usage on an active account, if there is usage on an inactive account, if a leak has been detected, and if there is reverse flow on the meter. The District's standard operating procedure is for the meter reader to check on these issues while reading or to follow up the next day to remedy any issues. The District does not have

historical data to confirm whether an alert was generated for the meter at 118 Wilson Lane during the relevant period; however, if an alert had been generated, it is the District's belief and practice that it would have been investigated. The District also removes and tests ERTs along with meters when they are removed from service.

QUESTION 5/6.

Refer to Grayson District's Responses to Staff's First Request, Items 1–4, and refer also to Grayson District's current tariff on file with the Kentucky Public Service Commission, tariff Sheet Nos. 18–19, with an effective date of 8/15/2005, Section F. Bill Adjustments, subpart 2. Meter read failure. Given that the ERT at 118 Wilson Lane was not properly functioning, explain why the instant complaint event does not qualify as a meter that has ceased to register or a meter reading that cannot be obtained.

ANSWER 5/6.

This complaint does not qualify as a meter that has ceased to register or a meter reading that cannot be obtained because the meter register itself continued to function normally and a reading of actual usage that had passed through the meter was able to be obtained. Once an ERT fails or becomes detached, it will continue to send the last reading it received from the meter register each time it is read. The meter reading system may have notified the District of low or zero usage; however, low or zero usage readings are common in the District's system. The District believes

the meter would have been checked if a warning was generated, but the District does not have a record of either a warning or the meter being checked during the relevant period. It is possible that the meter was checked at some point during that time and the reading was determined to be correct.

QUESTION 7.

Provide the actual water meter readings, not the ERT readings, for 118 Wilson Lane, Leitchfield, Kentucky 42754 for each month from September 2024 through September 2025.

ANSWER 7.

The only readings the District has for the meter at 118 Wilson Lane from September 2024 through September 2025 are the readings obtained by the ERT, with the exception of the reading taken in June of 2025 that determined a leak had occurred and that the ERT was not functioning properly. Those readings have been provided in a previous filing.

QUESTION 8.

If Grayson District were to calculate a water bill for the residence at 118 Wilson Lane, Leitchfield, Kentucky 42754 based upon an average of twelve-months' consumption, provide how the bill would be calculated and what the total bill amount would be.

ANSWER 8.

See attached. Note: The calculation attached is based on the usage at 118 Wilson Lane over the last 12 months, which includes the high usage in question. If that usage were not included, the customer's average usage would have been under the District's monthly minimum usage of 1,500 gallons. In that case, the bill would have been a minimum bill each month, which at current rates is \$26.24 including taxes.
