RE: Informal Conference of October 24, 2025

Pursuant to a Staff Notice issued on October 22, 2025, an informal conference was conducted on October 27, 2025. Attached is a copy of the attendance roster.

The purpose of the informal conference was to discuss issues presented in this matter, including the substantial recent increase in gas line loss on the Navitas KY NG, LLC (Navitas KY) distribution system and the measures Navitas KY has undertaken to identify and eliminate the sources of line loss. Commission Staff indicated that it could not speak for or bind the Commission.

Navitas KY personnel stated that a ruptured 4" line had been discovered and repaired in Albany County. Navitas KY further identified a vacant riser with a valve opened in Johnson County and leaking city gate regulators. Navitas KY stated that a line patrol was conducted to identify possible theft. Navitas KY also investigated whether the issue could be caused or made worse by underread customer meters. Navitas KY personnel stated that they expect the line loss to decline, and that it they should be able to tell if recent measures have been effective to reduce line loss by the end of October.

Commission Staff discussed with Navitas personnel and counsel the line loss limiter that applies to GCR calculations. Commission Staff also suggested that Navitas KY and its counsel consider filing into the record an explanation of the increased line loss and what Navitas KY has done to reduce it. Commission Staff suggested Navitas KY could request relief from the line loss limiter but reminded Navitas KY that they could not speak for the Commission and suggested that Navitas KY consult with their attorney regarding whether and when to request such relief.

There being no further discussion, the informal conference was then adjourned.
