ORDER

On December 19, 2025, the Commission established this proceeding pursuant to 807 KAR 5:056, Section 3(4) to examine Kentucky Utilities Company’s (KU) application of its Fuel Adjustment Clause (FAC) from November 1, 2022, through October 31, 2024, and established a procedural schedule.<sup>1</sup>

The Commission, on its own motion, finds that the procedural schedule issued December 19, 2025, should be amended. KU should request a public hearing or submit a request for the matter to be decided based upon the written record by June 1, 2026.

IT IS THEREFORE ORDERED that:

1. The procedural schedule issued on December 19, 2025, shall be amended.
2. KU shall request a public hearing or submit a request for the matter to be decided based upon the written record on or before June 1, 2026.
3. All provisions of the Commission’s December 19, 2025 Order that are in conflict with the provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
