ORDER

On December 19, 2025, the Commission established this proceeding pursuant to 807 KAR 5:056, Section 3(4) to examine Louisville Gas and Electric Company's (LG&E) application of its Fuel Adjustment Clause (FAC) from November 1, 2022, through October 31, 2024, and established a procedural schedule.<sup>1</sup>

The Commission, on its own motion, finds that the procedural schedule issued on December 19, 2025, should be amended. LG&E should request a public hearing or submit a request for the matter to be decided based upon the written record by June 1, 2026.

IT IS THEREFORE ORDERED that:

1. The procedural schedule issued on December 19, 2025 shall be amended.
2. LG&E shall request a public hearing or submit a request for the matter to be decided based upon the written record on or before June 1, 2026.
