My Name is James Goldsmith I live
in Airview Est. in E-Town KY 42701.

I am A Senior Citizen Living Alone
ON A Fixed Income. I am writing
PSC Again Asking For Help To get
Something Done About The Sewer Rates.

I use on average about 1500 Gal.
of water a month. Year round, \$20.⁰⁰

A month, Bluegrass Water, wants over
5-times more a month for sewer charge.

I have people living in my neighborhood
that use's 7000. to 8000. Gal. of water
a month, they pay the same as I do

for sewer charges. No matter how
much water they run through the
sewer system. Bluegrass Water
rating charges are \$77.⁷⁷ per 1000 Gal.

So why don't they charge the people that
use 5000 Gal. at \$77.⁷⁷ = \$388.⁸⁵

But they pay the same as I do.

We need help to get this billing
more fair.

What about Senior Citizens Living Alone
on a fix income NOT get charged more
than 3-times their water bill.

\$20.⁰⁰ water bill, \$60. sewer bill.

\$60.⁰⁰ water bill, \$180. sewer bill.

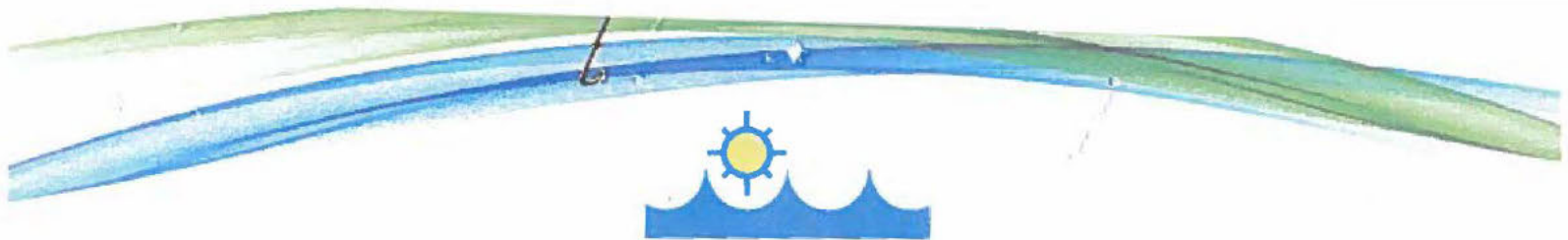
