ORDER

On December 30, 2025, East Kentucky Power Cooperative, Inc. (EKPC) filed a Notice of Intent and Election for a Certificate of Public Convenience and Necessity to construct new generation resources, issuance of a site compatibility certificate, and other generalized relief. EKPC’s original Notice of Intent and Election included a “no later than” filing date of January 16, 2026.

On March 19, 2026, EKPC filed a motion to close the case. EKPC cited Winter Storm Fern and “other numerous circumstances” caused EKPC to reconsider the timing and placement of the planned new generation.¹

Based on EKPC’s motion, and because EKPC’s originally proposed filing date has passed, the Commission finds that the motion should be granted, and this case should be closed and removed from the Commission’s Docket.
