Comments:

We are local organic farmers and complainants in active PSC Case No. 2026-00152. We are writing to formally object to KAW's requested \$108 million rate increase. KAW's project engineering logs from John Magner explicitly admit that the utility is operating an unpermitted, un-easemented multi-household distribution main across our private land in direct violation of 807 KAR 5:066, Section 15. Furthermore, KAW Vice President and General Counsel Anne Trout has explicitly stated in writing that the company is intentionally weaponizing the Commissions administrative backlog to stall our case and block a state-mandated highway safety driveway permit. KAW should not be granted system rate increases or infrastructure approvals while its executive leadership consciously flouts basic utility regulations and commits continuous property trespasses against small Kentucky businesses to save on corporate capital expenditure costs.
