ORDER

On March 31, 2026, Navitas KY NG, LLC (Navitas KY) filed its quarterly Gas Cost Recovery (GCR) rate report with a proposed effective date of May 1, 2026. Navitas KY also requested to suspend the residual surcharge of \$4.5000 per Mcf originally ordered in Case No. 2025-00316.<sup>1</sup>

KRS 278.030 provides that a utility may collect fair, just and reasonable rates and that the service it provides must be adequate, efficient and reasonable. Having reviewed the proposed GCR rate report and being otherwise sufficiently advised, the Commission finds that an investigation cannot be completed before May 1, 2026. Therefore, pursuant to KRS 278.190(2), the Commission will suspend the effective date of the proposed GCR rates for one day, until May 2, 2026, to give the Commission time to investigate the proposed GCR rates, and to allow Navitas KY to begin charging the GCR rates, pending a final Order and subject to refund, provided it provides written notice to the Commission of its intention to do so as required by KRS 278.190(2). Navitas KY should maintain its records in such a manner as will allow it, the Commission, or any customer to determine

the amounts to be refunded, and to whom, in the event a refund is ordered upon final resolution of this matter.

The Commission also finds an investigation cannot be completed before May 1, 2026 as to the suspension of the residual surcharge. Therefore, pursuant to KRS 278.190(2), the Commission will suspend the effective date of the proposed suspension of the residual surcharge for one day, until May 2, 2026, to give the Commission time to investigate the proposed suspension of the residual surcharge, and to allow Navitas KY to implement its requested suspension of the residual surcharge rate, pending a final Order, once it provides written notice to the Commission of its intention to do so as required by KRS 278.190(2).

The Commission directs Navitas KY to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>2</sup> in which the Commission mandated the use of electronic filing procedures listed in 807 KAR 5:001, Section 8. Consistent with the filing procedures set forth in Case No. 2020-00085, the Commission finds that electronic filing procedures should be used.

IT IS THEREFORE ORDERED that:

1. Navitas KY's proposed GCR and residual surcharge rates are suspended for one day, until May 2, 2026.
2. Navitas KY's proposed GCR rates may be placed in effect by Navitas KY on, or after May 2, 2026, pending the final Order in this matter and subject to refund,

provided Navitas KY files written notice to the Commission of its intention to do so as required by KRS 278.190(2).

3. Navitas KY's proposed residual surcharge may be suspended by Navitas KY on, or after May 2, 2026, pending the final Order in this matter, provided Navitas KY submits written notice to the Commission of its intention to do so as required by KRS 278.190(2).

4. If Navitas KY files notice of its intention to place the proposed GCR rates into effect after the end of the suspension period, Navitas KY shall maintain its records in such manner as will allow it, the Commission, or any customer to determine the amounts to be refunded and to whom in the event of a refund is ordered upon final resolution of this matter.
