ORDER

On June 5, 2026, Columbia Gas of Kentucky, Inc. (Columbia Kentucky), filed a motion requesting that the Commission schedule an Informal Technical Conference (ITC) for the purpose of discussing Columbia Kentucky’s filing and its responses to Commission Staff’s First Request for Information.¹

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Columbia Kentucky’s motion should be granted. In addition to the above stated purposes, Columbia Kentucky should be prepared to discuss the following:

- Columbia Kentucky’s Revenue Forecast for the test period;
- An overview of Columbia Kentucky’s forecasting methodology;
- Safety Modification and Replacement Program (SMRP) Rider Overview and whether the SMRP has historically been included in the base period;
- Calculation of the normalized “NCSC Billed to Columbia Labor O&M, STI O&M, and Payroll Tax Expense Adjustment,” specifically relating to the headcount complement adjustments.
- Rate Base Additions and how the forecasted capital spending ties into the forecasted Rate Base;
- An overview of the three filed Cost-of-Service Studies;
- The determination of Columbia Kentucky’s Revenue Allocation; and
- The Main Line Delivery Service block rate.
