ORDER

On May 22, 2026, Ohio Valley Gas Corporation (Ohio Valley Gas) moved the Commission to admit *pro hac vice* Rajan Kapoor, an attorney whose office is in Indiana, to practice law before the Commission on behalf of Ohio Valley Gas in association with Valerie T. 
