ORDER

On June 18, 2026, Duke Energy Kentucky, Inc. (Duke Kentucky) filed a request for waiver of the filing deadline established by the June 4, 2026 Order in Case No. 2024-00197¹ to file its Integrated Resource Plan (IRP) within 45 days of the issuance of the final rule in Environmental Protection Agency (EPA) Docket No. EPA-HQ-OAR-2024-0124.² On June 30, 2026, Duke Kentucky filed a motion to withdraw its request for waiver, stating that due to the uncertainty as to the timing of the issuance of the EPA final rule, it would be best to maintain the existing schedule set by the previous IRP proceeding.³ On July 2, 2026, the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) filed a motion to intervene.⁴

Having considered the motion and the material at issue, the Commission grants Duke Kentucky's request to withdraw its request for waiver to file its IRP early. The Commission notes that all future IRP filings should be made pursuant to the final Order

in Case No. 2024-00197. In addition, with the grant of Duke Kentucky's motion, the Commission finds that the Attorney General's request is moot.

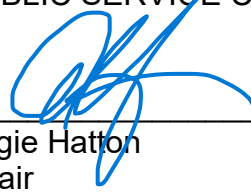
IT IS THEREFORE ORDERED that:

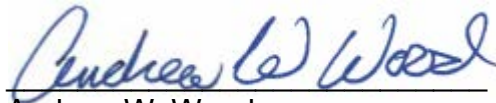

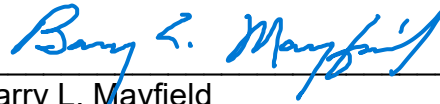
