ORDER

On September 10, 2026, Navitas KY NG, LLC (Navitas KY) filed a motion to request additional time to respond to the data request issued on August 31, 2026. The requested information is due on September 16, 2026, and Navitas KY requested to have until no later than September 30, 2026, to respond.

In support of the motion, Navitas KY described that it is leanly staffed and is involved in multiple contemporaneous purchased gas proceedings in other states.¹ Navitas KY stated that it continues to evaluate Staff's inquiries and is working to retrieve the relevant responsive information.² Navitas KY stated that this motion is made in good faith and not for purposes of delay.³ Navitas KY argued that its request for a brief extension will not delay this matter, nor will it prejudice any party or Navitas KY's customers.⁴

Having considered the record and being otherwise sufficiently advised, the Commission finds that Navitas KY's request for additional time should be granted for good

cause shown. The Commission agrees that allowing Navitas KY an additional two weeks will not prejudice any party or the customers and will allow Navitas KY to provide Staff with complete and thorough answers to Staff's questions.

IT IS THEREFORE ORDERED that:

1. Navitas KY's motion for additional time is granted.
2. Navitas KY shall file responses to Commission Staff's August 31, 2026, Request for Information no later than September 30, 2026.

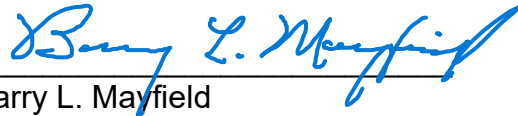
