Commission Staff has reviewed the application in the above case. This filing is rejected for the reason(s) set forth below.

Filing deficiency pursuant to:

1. 807 KAR 5:001 Section 14(3): If a limited liability company, the applicant shall identify in the application the state in which it is organized and the date on which it was organized, attest that is in good standing in the state in which it is organized, and if not a Kentucky limited liability company, state whether it is authorized to transact business in Kentucky; No authorization statement to transact business in Kentucky was provided with application.
2. 807 KAR 5:063 Section 1(1)(k): A map, drawn to a scale no less than 1 inch equals 200 feet, that identifies every structure and every owner of real estate within 500 feet of the proposed tower; Only maps identifying property owners were provided with application. Please provide maps of every structure with 500 feet of proposed tower.

The information necessary to cure the deficiency must be submitted within 10 days of the date of this letter.
