RE: Informal Conference of May 22, 2026

Pursuant to Staff Notice issued on May 20, 2026, an informal conference was conducted on May 22, 2026. Attached is a copy of the attendance roster.

The purpose of the informal conference was to discuss the filings in this case. Specifically, the parties discussed the final Order in Case No. 2025-00085.¹ Sentra and its counsel explained how they interpreted the final Order and applied that information to the filing in this matter. Staff and Sentra then walked through the actual adjustment calculation and the balancing calculation for the three previous quarters and current quarters as to what inputs should be and were used.

In addition, Staff asked what would have been helpful in the Order to clarify what was expected for the next filing. Sentra and its counsel mentioned specificity as to the periods or inputs as well as a possible example would be helpful when items needs to be addressed in the next filing. Sentra offered to file anything or respond to additional requests for information, if necessary, although Staff believes it should have received all the necessary information. The prospect of asking Staff questions informally between cases, particularly regarding process, was also discussed.

There being no further discussion, the informal conference was then adjourned.
