Pursuant to 807 KAR 5:001, Section 13(3), Kentucky-American Water Company ("KAWC") by Petition received April 30, 2014, requested confidential treatment of certain information filed with the Commission outside of a formal proceeding. 807 KAR 5:001, Section 13(3)(c), provides that the Commission's "executive director, as official custodian of the commission's records, shall determine if the material is within an exclusion established in KRS 61.878 and the time period for which the material should be considered as confidential and shall advise the requestor of his or her determination by letter." This letter constitutes my determination of your request.

The information you request the Commission treat as confidential is identified as being contained in materials filed in accordance with ordering paragraph 5 of the Commission's Order dated February 28, 2013 and more particularly described as "as built" drawings.

Your justification for having the Public Service Commission handle this material as confidential is that the public disclosure of the information could result in a threat to public safety.

Based on a review of the information and pursuant to KRS 61.878(1)(m)(1)(f) and 807 KAR 5:001, Section 13, the information requested to be held confidential if publicly disclosed could result in a threat to public safety. Therefore, the information requested to be treated as confidential **meets the criteria for confidential protection** and will be maintained as a nonpublic part of the Commission's file in this case for an indefinite

period of time, or until an Order of the Commission. The procedure for usage of confidential materials during formal proceedings may be found at Section 13(9) of 807 KAR 5:001.

If the information becomes publicly available or no longer warrants confidential treatment, Kentucky-American Water Company, by Section 13(10)(b) of 807 KAR 5:001, is to inform the Commission so that the information may be placed in the public record.
