Kentucky Power Company Summary of Demand Side Management Expenses Month Ended: May 2016

May expenditures of \$468,680 are above the budgeted amount of \$433,863 with a positive variance of \$34,818. Commercial program expenditures were \$57,092 above budget and residential program expenditures were \$22,274 below budget.

Two new commercial programs, Express Install and Retro-Commissioning, are in start-up mode and together these two programs account for a \$248,093 shortfall in the YTD commercial program budget. Both programs are anticipated to have full participation by the end of the program year. Potential customer projects have already been identified for the Retro-Commissioning program and are anticipated to begin during the 2nd half of 2016. Customer projects are expected to begin in July for the Express Install program following the program launch to customers.

The Commercial Incentive Prescriptive Custom program (CIPC) was above budget for May having 81 customer projects completed. For YTD, the CIPC is above budget by \$109,101.

The Residential Efficient Products program was below budget for May by \$18,130. Customer demand for energy efficient lighting and appliances offered through the program remain high as represented by YTD paid incentives to customers totaling \$373,727 or approximately 60% of the annual customer incentive program goal.

The Whole House Energy Efficiency program is \$31,933 above budget for May having completed 39% of single family home energy audits and having HVAC measures completed at 60% of the annual measure target.

The Targeted Energy Efficiency weatherization program is below the YTD budget by \$105,310. The primary reason for the lower than expected YTD performance is because of local agencies utilization of LIHEAP funds currently available through the Weatherization Assistance Program. The future trend for home audits and weatherization services is positive as the Community Action agencies increase the audits and weatherization services provided through the DSM program. Expanding the program with approved measures like energy efficient windows should support added investment in the DSM program.
