Kentucky Power Company Summary of Demand Side Management Expenses Month Ended: March 2016

March expenditures of \$770,882 are below the budgeted amount of \$928,310 with a negative variance of \$157,428. Commercial program expenditures were \$169,543 below budget and residential program expenditures were \$12,115 above budget. Year-to-date, 2016 DSM/EE expenditures are \$346,863 below the budgeted amount. Commercial program expenditures are \$167,753 below budget and residential program expenditures are \$179,110 below budget.

Two new commercial programs, Express Install and Retro-Commissioning, are beginning to start-up. The Company is anticipating full participation for the remainder of 2016. Together, these two programs account for \$149,493 of the YTD negative variance in the commercial program budget.

The Targeted Energy Efficiency weatherization program is behind in the number of homes anticipated for audit and weatherization services. The reduction is primarily attributed to reduced invoices from Community Action for completed home audits. Kentucky Power is coordinating with CAA to ensure the maximum potential for utilizing the program services and expects an increase in program participation as one agency returns to full capacity following the establishment of a quality control inspector.

Setup and integration is ongoing with a new implementation contractor for the Appliance Recycling program. The anticipated program launch date is late April and estimated participation remains consistent with the original program target.

New program services are being developed with DSM implementation contractors. Several of the new programs are presently behind the YTD budget target but implementation schedules are being developed in conjunction with contracting services to achieve annual program goals. Two residential programs, New Manufactured Homes and Whole House Efficiency, account for \$108,928 of the YTD negative variance in the residential program budget.
