
On January 10, 2022, the Commission received requests from Daniel Hunt, pursuant to the Kentucky Open Records Act, KRS 61.870, et seq., and 807 KAR 5:001, Section 13, to inspect materials that Duke Energy Kentucky, Inc. (Duke Kentucky) filed in Case No. 2019-00361 and Case No. 2019-00251. Copies of the requests, and the Commission's response to the requests, are attached to this letter.

807 KAR 5:001, Section 13(10)(d) requires that the Commission notify Duke Kentucky of the request and allow Duke Kentucky 20 days in which to file a response to the requests for inspection. Accordingly, Duke Kentucky is directed to file, within 20 days of receipt of this letter, and through the Commission's electronic filing system in each docket of the cases for which inspection has been made, a response to the requests to inspect the confidential material. Please also send a copy of the response to Mr. Hunt. Specifically, 807 KAR 5:001, Section 13(10)(d) requires that Duke Kentucky demonstrate that the confidential material still falls within the exclusions from disclosure requirements established in KRS 61.878. If Duke Kentucky is unable to make such a demonstration, the Commission will grant Mr. Hunt's requests and make the records at issue available for public inspection.
