The linked case file includes items that were identified as responsive to the request but were previously granted confidential treatment pursuant to 807 KAR 5:001 Section 13. Pursuant to 807 KAR 5:001 Section 13(10)(d), 807 KAR 5:001 Section 13(7), (8), and KRS 61.872(5), the PSC will send notice to the parties that originally requested the items be granted confidential treatment. Those parties will be given 20 days of receipt of the notice to demonstrate that the material still falls within the exclusions from disclosure requirements established in KRS 61.878. If the parties are unable to make the demonstration, the PSC shall make the requested materials available, or if the party is able to make the demonstration, the PSC shall deny the requested inspection.

If you wish to appeal this decision, you may do so by filing a complaint with the Kentucky Office of the Attorney General, Open Records/Open Meetings Division, The Capitol, 700 Capitol Avenue, Suite 118, Frankfort, KY 40601, pursuant to KRS 61.880(2), or by filing an original civil action in the Franklin Circuit Court under KRS 61.882. If you first appeal to the Attorney General but are dissatisfied with the Attorney General's decision, you may further appeal to circuit court pursuant to KRS 61.880(5).
