RE: Informal Conference of September 17, 2024

Pursuant to an Order dated September 16, 2024, an informal conference (IC) was conducted on September 17, 2024. Attached is a copy of the attendance roster. The purpose of the IC was to discuss Mountain Water District's concerns regarding the rates granted by the Commission in this matter. Mountain District reported that it is under-recovering revenue from its water and sewer rates when compared to the revenue projected to be recovered from the approved rates. Mountain District explained it believes that the under-collection may be, in part, due to the decrease in minimum monthly charge to customers.

Mountain District also discussed possible remedies to alleviate the impact of the under-collection on the district. Commission Staff informed the participants that Staff would review the matter and, as always, the Commission would consider any future filings of the Mountain District seeking to address the under-collection. There being no further discussion, the IC was then adjourned.
