To whom it may concern:

Pursuant to the final order in Administrative Case No. 327 ("Admin 327") issued on September 24, 1990, formal guidelines were established for electric and gas utilities with respect to the implementation of economic development rates ("EDR"). Among other things, the Commission in Admin 327 found and directed that electric and gas utilities that have active and Commission-approved EDR special contracts "should file an annual report with the Commission detailing revenues received from individual EDR customers and the marginal costs associated with serving those individual customers." The Commission also found and directed all electric and gas utilities with active and Commission-approved EDR special contracts to file an annual report with the Commission providing the information set forth in Appendix A to the Commission's 1980 order (included as an attachment to this letter).

Given that the final order in Admin 327 was issued over 25 years ago, the Commission wants to take this opportunity to remind each jurisdictional electric and gas utility with active and Commission-approved EDR special contracts of these two annual filing requirements. The two annual filing requirements should be submitted by March 31 of each year. The filing requirement for the detailed revenues and marginal costs for individual customers applies only during the period associated with the discounted rate.
