

**AFFIDAVIT**

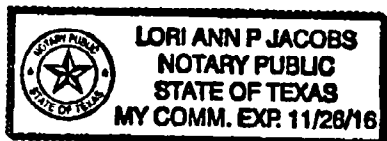
Comes, Affiant, Dell Purdy, and after first being duly sworn, states as follows:


