Mr. Wuetcher,

Per your request, attached please find our letter adding 2 Notes to the South Eastern Water Association Case No. 2010-00431.

Also, in response to your inquiry about the lending agencies, we had previously filed letters correcting the lending agency in Cases No. 2010-00411 and 2010-00419. We have attached the letters to this email.

In regards to the structure of these 5 refunding cases, State and Federal tax laws prohibit the Kentucky Rural Water Finance Corporation from making tax-exempt loans to water associations as such associations are "private parties" under tax laws. It was necessary to have the County of Butler issue tax-exempt pooled private activity bonds to accomplish the water association refundings in order to comply with all laws. The County of Butler agreed to act as the pool issuer in order to take advantage of the economies of scale, as opposed to issuing 5 separate bond issues in each County where the water associations are located.

Mr. Jones:

This message is to confirm the requests made during our telephone conversation this morning.

First, applications for PSC approval to refund certain loans in Cases No. 2010-00411, No. 2010-00419, No. 2010-00430, No. 2010-00431, and No. 2010-00439 refer to different lending agencies to which the water associations are executing loan agreements. Some of the applications refer to Kentucky Rural Water Finance Corporation. Others refer to the County of Butler. Which is the correct lending agency? If the lending agency is the County of Butler, Kentucky, please explain how this governmental body became a lender to several water utilities that are distant from Butler County.

Second, in Case No. No. 2010-00431, the application states that Southeastern Water Association is refunding 3 promissory notes held by Rural Development. The exhibits to the application involving existing promissory notes to be refunded have information on five promissory notes. How many notes are being refunded? If more than 3 notes are being refunded, please provide the same information for the

missing notes that was provided in paragraph 5 of the application for the other promissory notes.

Thank you for your prompt attention to these requests. Based upon the information provided this morning, Commission Staff understands that the applicants intend to close on the refinancings on 8 December 2010 and request an order from the Commission on their applications before that date.

We are writing this letter in response to a request from Gerald E. Wuetcher, Executive Advisor, regarding the above referenced Case.

Please be advised that South Eastern Water Association added two additional Notes to the refunding program subsequent to the filing of the initial Application for a total of five Notes. The information on the additional two Notes is as follows: (i) South Eastern Water Association Promissory Note, dated September 14, 1995, in the original principal amount of \$557,413.09, bearing interest at the rate of 5.00% per annum; and (ii) South Eastern Water Association Promissory Note, dated February 12, 1997, in the original principal amount of \$752,084.94, bearing interest at the rate of 5.00% per annum. Both additional Notes are currently held by USDA, Rural Development.
