

On May 1, 2011 Navitas KY NG was unable to submit the PGA filing covering the period November 1, 2010 through January 31, 2011. Navitas acquired the system serving the City of Albany and portions of Clinton County on or about the close of business February 28, 2011 from the former operator Gasco through the U.S. Bankruptcy Court.

As of this writing, Gasco has yet to provide the information associated with the gas costs or sales since for the time period of their last filing through the closing. We are in contact with the bankruptcy attorney and have requested this data on numerous occasions over a period of some months and have received assurances that it is being complied.

It is our intent to file our expected gas costs, on or before Monday, June 13, 2011, after I have met with you on June 7 to discuss our filing requirements.
