Dear Chuck:

Thank you for following up with the Commission earlier this year regarding the requirement, set forth in Appendix B to the August 2, 2011 Order entered in Case No. 2011-00124, that Duke Energy Kentucky (Duke) schedule a CEO meeting with the Commission and its staff annually. As you know, the Commission and its staff last met with Duke Energy's CEO Lynn Good on October 24, 2017.

Please be advised that the Commission has reevaluated this meeting requirement and determined that, absent any pressing need for a CEO discussion to be held, such meetings with the Commission and its staff need only occur once every two years. Since Duke met with the Commission and its staff in 2017, the next meeting to be scheduled per the requirements in Case No. 2011-00124 should be scheduled in 2019.
