SUBJECT: Informal Conference

A telephonic informal conference (“IC”) was held in this matter on Wednesday, August 10, 2011. Representatives of Atmos Energy Corporation (“Atmos”) and Commission Staff (“Staff”) participated in the IC. A list of the participants is attached.

The purpose of the IC was to discuss the rate design used in calculating the rates as shown in Exhibit I of Atmos’s application.

Discussion at the IC was initiated by Staff regarding Atmos’s method of calculating the rates, including how rounding affected the calculations. Discussions also involved Staff’s alternative calculation of rates. Atmos agreed to review the rates as filed to see if any changes needed to be made and agreed to file any changes deemed necessary.

The IC was then adjourned.

Atmos filed revisions to its rates calculations on August 19, 2011.
