SECTION 7: UTILITY COMMENTS

The Company continues to see positive results from its vegetation management program. Evidence suggests a more consistent positive reliability trend in the future. The 2016 Tree Inside of ROW SAIDI declined 43% compared to the previous five year average performance. Weather events now require more sustained and higher wind speeds to produce damage to the Company's facilities.

Excluding major events as defined by IEEE standard 1366, Kentucky Power's overall 2016 system performance for System Average Interruption Duration Index (SAIDI) and System Average Interruption Frequency Index (SAIFI) were lower than the previous five-year averages. The 2016 SAIFI and SAIDI indices were 2.175 and 446.2 respectively. The previous five-year averages for the SAIFI and SAIDI indices were 2.497 and 483.3 respectively. The Company's 2016 SAIFI and SAIDI indices also improved over the 2015 SAIFI and SAIDI indices of 2.464 and 467.8 respectively.

The Company's JMED is declining but remains high. It declined by approximately 27% from 6,264,399 total customer minutes interrupted in 2012 to 4,567,655 total customer minutes interrupted in 2016. Starting in 2018, when the 2012 Derecho will be eliminated from the trailing five-year average the Company is hopeful that that the daily MED will be normalized so that year-to-year comparisons of SAIDI will be more useful.

Kentucky Power Company remains committed to its reliability and vegetation management
