

The monthly charge for water usage in excess of the respective minimum usages listed in the water rates set out on the preceding page shall be computed in increments of 10 gallons. Accordingly, a customer having a 5/8 inch meter who consumes at least 2,010 gallons of water and not more than 2,019 gallons of water in any month shall pay the amount of \$17.44 for the month (a \$17.38 minimum bill plus \$0.06 for water usage in excess of the usage included in the minimum bill). And a customer having a 5/8 inch meter who consumes at least 2,020 and not more than 2,029 gallons of water in any month shall pay the amount of \$17.50 for the month (a \$17.38 minimum bill plus \$0.12 for water usage in excess of the usage included in the minimum bill).
