Thank you for following up with the Commission regarding the requirement, set forth in the final order in Case No. 2012-00133, that your client, Water Service Corporation of Kentucky (WSCK), meet with the Commission and its staff annually. Please be advised that the Commission has reevaluated this meeting requirement.

Absent any pressing need for a CEO discussion to be held, such meetings with the Commission and its staff need only occur once every two years. (In the event that either the Commission or WSCK believes there is a need to schedule a CEO meeting in the interim, the Commission's normal meeting scheduling procedures should be followed). Since WSCK met with the Commission and its staff in 2017, the next meeting to be scheduled per the requirements in Case No. 2012-00133 should be scheduled in 2019.
