Mr. Hampton's cabin is in my opinion should be served by AEP-Kentucky Power as my GPS coordinates, (-82.801777 37.878145), indicate a point of service to be approx. 32.5 feet south of the estimated Big Sandy RECC territory. The current closest point of service, -82.796 37.880, would require more than 2000 feet of primary construction. This cabin is indicated by the house on Map 1, a black dot on Map 2 & Map3.

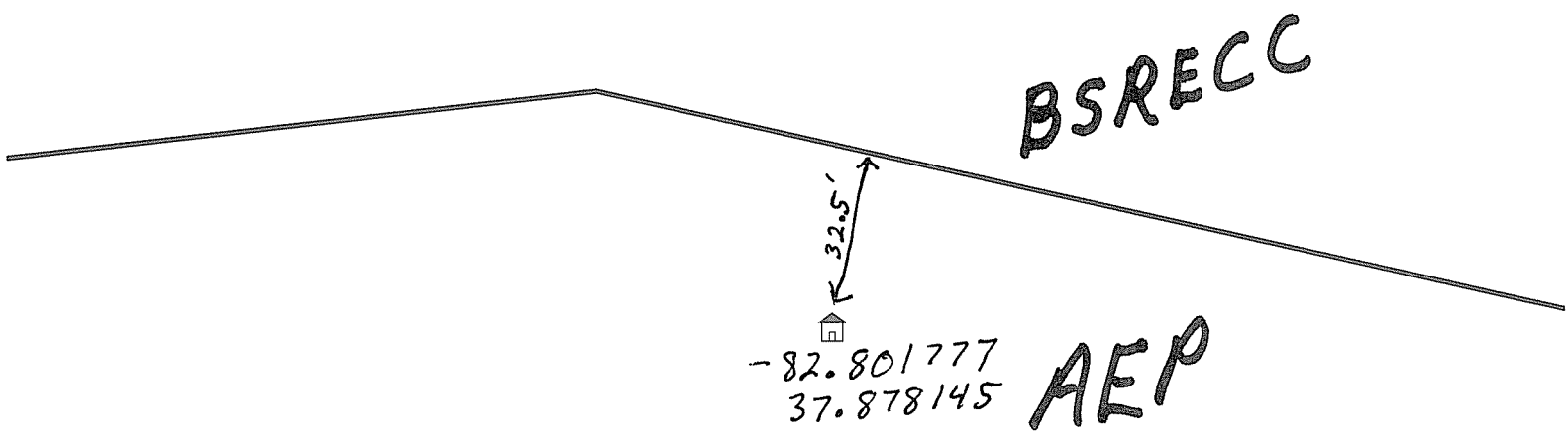

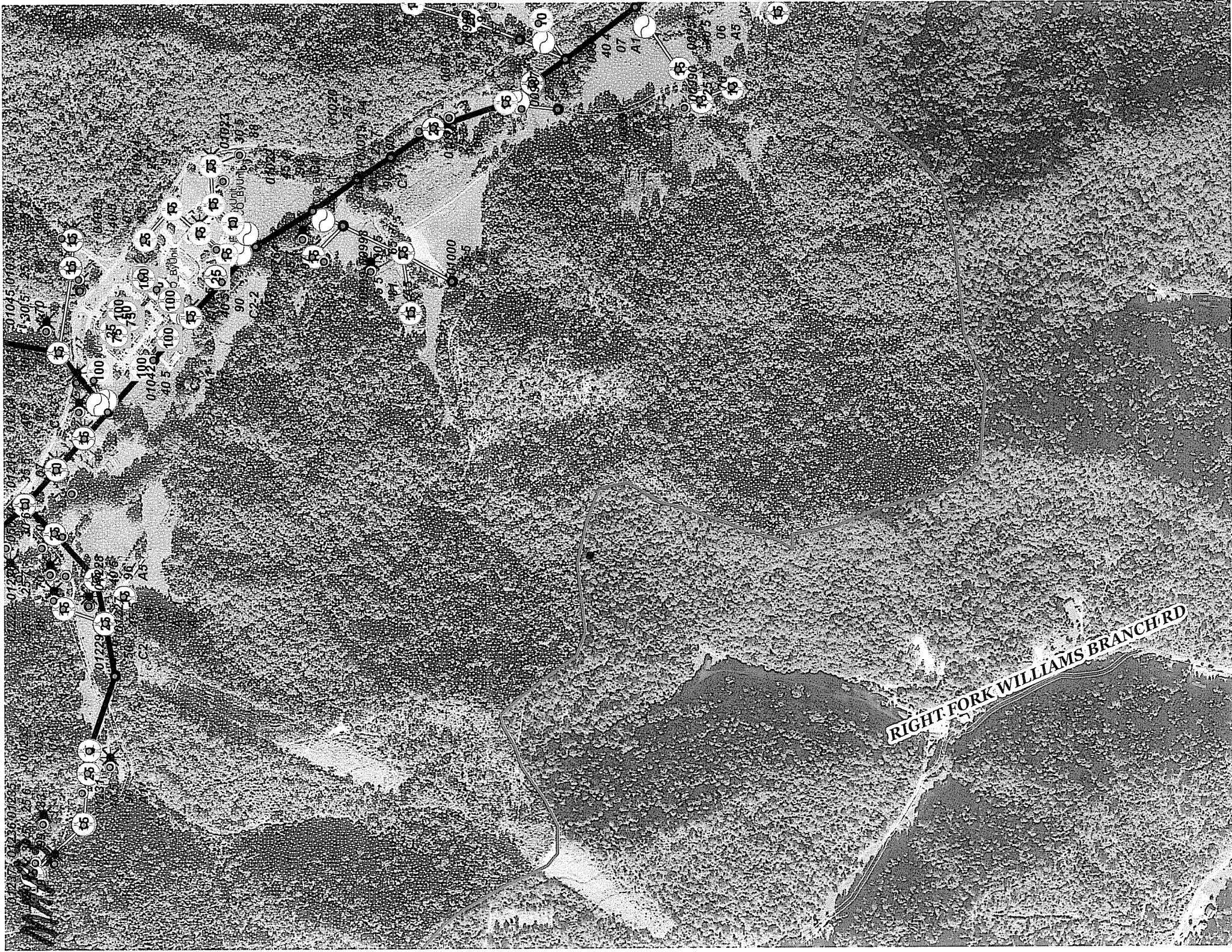
