Kentucky Power Company's Report On Issuance Of Evidences Of Indebtedness

In accordance with the Commission's September 26, 2014 Order in this proceeding, Kentucky Power Company reports that on November 5, 2014 it entered into a \$75,000,000 variable rate Credit Agreement, through the Company's Local Bank Financing Program, due November 5, 2018. Advances of \$50,000,000 currently are outstanding. The Company paid or estimates that it will pay 0.25% for the Up-Front fees or commission and 0.43% for fees and expenses. Interest on the advances is payable on the last day of each 3 month interest period, commencing February 5, 2015.

No Treasury Hedge or Interest Rate Agreements were used in connection with the issuance.

Kentucky Power apologizes for its delay in making this report.
