Kentucky Power Company's August 31, 2016 Supplemental Report On The Issuance Of Evidences Of Indebtedness

As previously reported, and in accordance with the Commission's September 26, 2014

Order in this proceeding, Kentucky Power Company on November 5, 2014 entered into a

\$75,000,000 variable rate Credit Agreement, through the Company's Local Bank Financing

Program, due November 5, 2018. Advances of \$50,000,000 were outstanding at the time of the

May 29, 2015 prior report.

Subsequent to the May 29, 2015 report, Kentucky Power on October 8, 2015 made an additional \$25,000,000 draw under the program. Advances of \$75,000,000 currently are outstanding and Credit Agreement is at full capacity.

The Company paid or estimates that it will pay 0.25% for the Up-Front fees or commission and 0.43% for fees and expenses. Interest on the advances is payable on the last day of each 3 month interest period.

No Treasury Hedge or Interest Rate Agreements were used in connection with the issuance.
