Dear Mr. Derouen:

On March 16, 2015 it was brought to my attention by Commission Staff that the Company inadvertently filed unredacted copies of Attachment 2 through Attachment 29 of the Company's September 15, 2014 response to KIUC 1-2 in the above proceeding. The attachments should have been redacted to obscure, in conformity with 807 KAR 5:001, Section 4(10(a)(3), certain financial account information.
