

**Customer Notice - Elizabethtown Water Service Area Public Service Commission**  
Notice is hereby given that Hardin County Water District No. 2 (the "Water District") received approval from the Kentucky Public Service Commission (see Case No. 2014-00289) on October 23, 2014: (i) to incur a long-term debt for the purpose of acquiring Elizabethtown's Water System Assets; and (ii) to implement the Elizabethtown Water Rate Tariff Schedule set forth in Elizabethtown Ordinance No. 07-2014 enacted on February 18, 2014. These rates will be applicable to former Elizabethtown water customers and customers receiving water service in the former Elizabethtown Water Service Area. These rates will not apply to residents of Elizabethtown who were already customers of the Water District prior to the acquisition of the Elizabethtown Water System Assets on October 31, 2014. The Elizabethtown Water Rate Tariff Schedule contains four (4) step rate increases. As approved by the Public Service Commission, Step 1 rates were effective from November 1, 2014 through June 30, 2015, Step 2 rates were effective from July 1, 2015 through June 30, 2016, and Step 3 rates were effective from July 1, 2016 through June 30, 2017. The Step 4 rates, as shown in the chart set forth below, will become effective for water service rendered by the Water District on and after July 1, 2017.

The Step 4 rate increase will cause the monthly bill for a residential customer using an average of 5,000 gallons per month to increase from \$31.75 to \$33.95. This is an increase of \$2.20 or 6.9%. The rates contained in this notice are the rates set forth in Elizabethtown Ordinance No. 07-2014 enacted by the Elizabethtown City Council on February 18, 2014. As part of its agreement to purchase the Elizabethtown Water System Assets, the Water District agreed to seek approval from the Public Service Commission to implement the Elizabethtown Water Rate Tariff Schedule for the current Elizabethtown water customers and future water customers receiving water service in the Elizabethtown Water Service Area. The Public Service Commission, by an Order issued on October 23, 2014 in Case No. 2014-00289, approved the rates contained in this notice for water service rendered on and after July 1, 2017. The Water District has available for inspection at its office the application which it submitted to the Public Service Commission.
