

The PSC Staff Report for the above referenced case calculated a rate increase of 26.56%. In a letter dated July 31, 2016, a request was made to only raise the rate 15%. This 15% increase was put in place in the August 17, 2016. This rate increase has proven to be insufficient to generate the necessary revenue for the water district. At this time the Morgan County Water District requests the PSC to allow us to raise rates to those calculated in the staff report dated July 11, 2016 (attached).
