

CUSTOMER NOTICE

Due to a rate increase from the City of Murray Water & Sewer System, notice is hereby given that the South 641 Water District has filed an application for a Purchased Water Adjustment with the Kentucky Public Service Commission for adjusting its water rates. Customer rates will increase \$0.26 per 1,000 gallons used. The proposed charge will be effective for service rendered on and after January 1, 2017.

Monthly Water Rates

The monthly bill for a residential customer using an average of 5,000 gallons per month will increase from \$40.86 to \$42.16. This is an increase of \$1.30 or 3.2%.

The rates contained in this notice are the rates proposed by South 641 Water District. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates shown in this notice.


