

Each of the contracts previously was filed with the Commission.

Kentucky Power Company filed on July 3, 2019 the June 7, 2019 special contract between Kentucky Power Company and the High Ridge Mining LLC. The agreement provides for service to the customer’s facilities located at 6181 State Road 194 East, Kimper, Pike

County, Kentucky. The High Ridge Mining LLC special contract is pending Commission review. The contract expires two years following the date of its approval by Commission action or operation of law.


