Per the PSC Order dated July 19, 2019, please note the following update regarding the Todd County Water District's Novelis Water Supply Project:

- Contract 1 (Line Extension & Meter Station) was substantially complete as of November 25, 2019. The Contractor (Horsley Construction) was notified on December 4, 2019. Asbuilt drawings were forwarded to PSC in October 2020.
- Contract 2 (Tank Addition) was substantially complete as of October 8, 2020. The Contractor (Caldwell Tanks) was notified on October 14, 2020. Asbuilt drawings were forwarded to PSC in October 2020.
- Contract 3 (Line Extension & Meter Vaults) was substantially complete as of June 14, 2021. The Contractor (Abbico Contracting, LLC) was notified on June 23, 2021. Asbuilt drawings for this contract are enclosed.

As of June 14, 2021, Abbico Contracting LLC substantially completed work on the third contract of the referenced project. This milestone is all in conjunction with the successful pressure testing, disinfection, placement of the waterline extension into service, and successful installation of five new master meter vaults. Final completion of the contract's cleanup is in progress, and it is expected to be completed in the near future.

Based upon our firm's knowledge and witness of the work, we believe that the work was performed in accordance with plans and specifications approved by the Water Infrastructure Branch of the Division of Water on February 13, 2020. Therefore, the warranty period for Contract 3 of the project will run respectively for a 12-month period ending on or near **December 1, 2021** (Line Extension Portion) and **June 14, 2022** (Vault Installations).
