



Notice is hereby given that because of an increase in the cost of water purchased from Campbellsville Municipal Water & Sewer, the Marion County Water District will increase its rates for services effective July 1, 2019. An application requesting the proposed rates was filed with the Kentucky Public Service Commission on June 12, 2019 to increase rates as follows:

As noted above, based on the increased cost of water from Campbellsville Municipal Water & Sewer, all rates will increase by \$0.01 per 1,000 gallons. The monthly bill for an average residential customer using 5,350 gallons of water each month will increase from \$41.05 to \$41.10. This is an increase of \$0.05 or 0.12%.

The charges/rates contained in this notice are the charges/rates proposed by the Marion County Water District. However, the Public Service Commission may order charges/rates to be charged that differ from these proposed charges/rates. Such action may result in charges/rates for consumers other than the charges/rates detailed in this notice.
