*What wonderful news you have given !!*

“As of June 20, 2023, Mayfield Electric and Water Systems will be the new owner of the lagoon system and take on all responsibility.”

That is indeed great news for all “paying participants” of the lagoon system. You will “provide exceptional customer service along with a monthly bill that is much more suitable (\$55.00 per household).” PLEASE note, that I choose to use the term “paying participants”. . . that is in reference to those of us in the Randview Subdivision who meet that term. Assuming you used a list provided to you by the former owner, all should have received your letter of June 22, 2023. \$55.00 per household is indeed a much “more suitable”(and in my opinion, **honest**) rate for your “paying participants”. It is a “savings of over \$30.00 per month for your “paying participants” (WE THANK YOU). Recently, our former owner, Bluegrass Water UOC, LLC had petitioned the Kentucky PSC for approval to raise our monthly rates from \$85.97 to just under \$100.00 per month (it was not approved).

--- By the way, I personally can understand the \$55 per month (each household).... We all hope it covers all the clean-up, repairs, and improvements our lagoon will require. The previous owners spent “how much” on its maintenance ???

Again, we (the “paying participants”) are grateful for MEWS’s (our local utility provider) purchase of the lagoon system. We are also supportive of your stated “long-term goal to get the effluent to the Mayfield Wastewater Treatment Plant.” We do understand that it could be awhile for that to occur.... when “funds or grants become available.” WE, your “paying participants”, will welcome that day when our wastewater system can be modernized, and our monthly bills can then be structured (lowered) as they are within the city of Mayfield ...  
i.e. principally based on the amount of water a household uses, rather than a calculated amount considering the number of “known” lagoon participants.

We certainly send along our thanks to not just MEWS, but also to the Graves County Fiscal Court and its Judge Executive, Mr. Jesse Perry..... Indeed, “this purchase could not have been made without their generous support from the ARPA fund”.

Lastly, we “paying participants” in the Randview lagoon system are trusting and sincerely hoping that MEWS will make good in its promise to “provide the best service for the customers of the Randview Subdivision”. WE, the “paying participants”, would



hope that MEWS will **CERTIFY** that all residents who are using our lagoon system will be **“paying participant”** members (and not using the system on a **FREE** basis). We acknowledge that there are Randview Subdivision residents that **do have private septic lateral line systems** (approved by MEWS and the Graves County Health Department)... They are ... and should be... exempt from any monthly payment fee at this time. All other residents of the Randview Subdivision (not having that approved private system) **must be on the lagoon system, and MUST be “paying participants”**.  
Again, please **CERTIFY** such.

To the Customers of Randview Subdivision:

As you are aware we have been in purchase negotiations with Bluegrass Water UOC, LLC which is the current provider for the Randview Subdivision sewage disposal. As of June 20, 2023, Mayfield Electric and Water Systems will be the new owner of the lagoon system and take on all responsibility.

Our most important goal is to provide the best service for the customers of the Randview Subdivision. Therefore, as of June 21, 2023 Mayfield Electric and Water Systems assumed all responsibilities of the lagoon system, and we want you to be aware that you will be seeing Mayfield Electric and Water Systems employees, fleet, and equipment in your area frequently performing maintenance to get the lagoons set to our standards, and we hope this will not be an inconvenience.

The long-term goal is to get the effluent to the Mayfield Wastewater Treatment Plant, but until then we will have to service the lagoons until funds or grants become available.

Our flat customer fee will be \$55.00 per household, but the most noticeable change is that Mayfield Electric and Water Systems will strive to provide exceptional customer service along with a monthly bill that is much more suitable.

Bluegrass Water UOC, LLC's last and final billing cycle for the June service will be pro-rated through June 20th. That bill will be mailed the week of July 3<sup>rd</sup> and must be paid as normal to Bluegrass Water UOC, LLC. If you are currently billed for electric and/or water service with MEWS, then your sewer billing will be added to that bill so that you can make one payment for all services. Your first sewer bill will be pro-rated from June 21, 2023. Payments can be made in-person at 408 East Broadway, Mayfield, KY 42066 or mailed to PO Box 347, Mayfield, KY 42066.

Last but not least, we want to send many thanks to the Graves County Fiscal Court and Judge Executive, Jesse Perry because this purchase could not have been made without their generous support from the ARPA funding in the amount of \$175,000.00.
