

**AMENDMENT NO. 2 TO AGREEMENT FOR ELECTRIC SERVICE**

**THIS AMENDMENT NO. 2 TO AGREEMENT FOR ELECTRIC SERVICE** ("Amendment") is made and entered into this 31 day of AUGUST, 2015, by and between Kenergy Corp., 6402 Old Corydon Road, Henderson, Kentucky 42420 (hereinafter called the "Seller"), and Armstrong Coal Company, Inc. with a service address at Armstrong Dock, 660 A12 Road, Centertown, Kentucky 42328 (the "Armstrong Dock") and corporate address at 407 Brown Road, Madisonville, Kentucky 42431 (hereinafter called the "Consumer");

**WITNESSETH:**

(1) Seller and Consumer entered into an Agreement for Electric Service dated December 9, 2008 ("Agreement");

(2) Seller and Consumer amended the Agreement on August 10, 2010;  
and

(3) Seller and Consumer desire to amend said Agreement concerning the limits of Consumer's Maximum Demand;

**NOW**, therefore, in consideration of the promises and covenants hereto, and other valuable consideration, receipt being acknowledged, **IT IS AGREED** that said December 9, 2008, Agreement and said August 10, 2010, Amendment No. 1 are amended as follows:

1. Section 2.B. is deleted in its entirety and substituted therefor is the following:

B. Consumer's Maximum Demand under this Agreement is 12,000 kW with a Minimum Contract Demand of 60% of the Maximum Demand or 7,200 kW, subject to the provisions of Sections 2.H and 7 of this Agreement.



3. In all other respects the terms and conditions of said December 9, 2008, Agreement and the August 10, 2010, Amendment No. 1 for Electric Service are adopted and reaffirmed in their entirety.


