Re: An Electronic Examination by the Public Service Commission of the Environmental Surcharge Mechanism of Louisville Gas and Electric Company for the Six-Month Billing Periods Ending April 30, 2020, October 31, 2020, October 31, 2021, April 30, 2022, October 31, 2022, and October 31, 2023, and for the two-year billing periods ending April 30, 2021 and April 30, 2023 Case No. 2023-00375

Dear Mr. Bryant:

On January 3, 2023, the Kentucky Public Service Commission ("Commission") established the abovereferenced case to review and evaluate the operation of the Environmental Cost Recovery mechanism ("ECR") of Louisville Gas and Electric Company ("LG&E") for the (1) six-month review period of LG&E's environmental surcharge for expense months ending April 30, 2020, October 31, 2020, October 31, 2021, April 30, 2022, October 31, 2022, and October 31, 2023; and (2) the twoyear review period of LG&E's environmental surcharge for the expense months ending April 30, 2021, and April 30, 2023.

On August 30, 2024 the Commission issued an Order approving LG&E's proposed base ECR component, effective with bills rendered September 30, 2024. This adjustment resulted in changes to the rates for electric service under the power contract dated October 10, 1961, between LG&E and Louisville Water Company.

The revisions applicable to electric service under the power contract dated October 10, 1961, between LG&E and Louisville Water Company, are set forth below:
