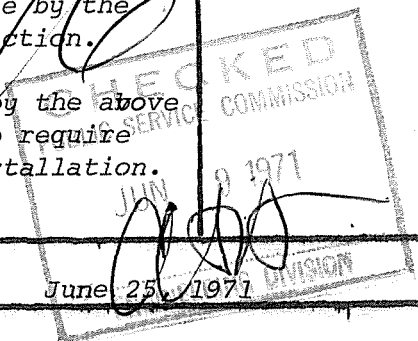

Over	1000 per month	@.012 per KWH

CONDITIONS OF SERVICE

1. Street lighting equipment including lamps, fixtures, and other necessary facilities including electric energy, will be furnished by the Cooperative.

2. Lamp replacements will be furnished and made by the Cooperative except in cases of vandalism or willful destruction.

3. Should the service required be other than by the above standard provisions, the Cooperative reserves the right to require payment from the consumer for the initial cost of such installation.

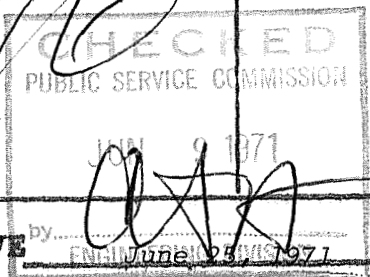
