Power factor may be measured at any time. <p><u>* FUEL ADJUSTMENT CLAUSE</u> The above rate may be increased or decreased by an amount per KWH equal to the fuel adjustment amount per KWH billed by the Wholesale Power Supplier plus an allowance for line losses. The allowances for line losses will not exceed 10% and is based on a twelve month moving average of such losses.</p> <p><u>MINIMUM CHARGE</u> The minimum monthly charge shall be the highest one of the following charges:</p> <p>(a) The minimum monthly charge as specified in the Contract for Service.</p> <p>(b) A charge of \$0.75 per KVA per month on contract capacity.</p> <p><u>CONDITIONS OF SERVICE</u> An "Agreement for Purchase of Power" shall be executed by the consumer for service under this schedule.</p> <p><u>CHARACTER OF SERVICE</u> Three-phase, 60 cycles, at standard secondary voltage. If other than standard secondary voltage is required the consumer shall be responsible for furnishing and maintaining the transformer (or transformers) necessary for such service.</p> <p><u>SPECIAL PROVISIONS</u> 1. <u>Delivery Point</u> * * If service is furnished at secondary voltage, the delivery point shall be the metering point unless otherwise specified in the Contract for Service.
