


**ADOPTION NOTICE**

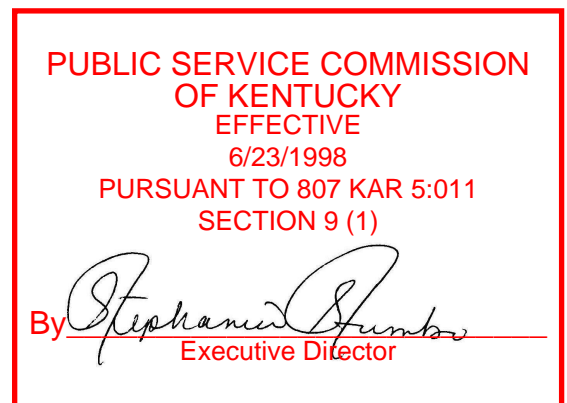

This notice is issued on the 12th day of May, 2008, in conformity with 807 KAR 5:011, Section 11, of the Regulations for the filing of Tariffs of Public Utilities with the Public Service Commission of Kentucky.

RULES AND REGULATIONS

The Company may impose the following special charges:

Turn-on Charge - A turn-on charge of \$25 will be assessed for a new service turn-on, service reinstatement, seasonal turn-on or temporary service. A turn-on charge shall not be made for initial installation of service where a tap fee is applicable, pursuant to 807 KAR 5:026, Section 7.

Installation Charge - The Company may impose an initial installation fee of \$150 for each service tap including saddle and first shut-off valve installed by the Company, pursuant to 807 KAR 5:026, Section 9.

Meter Test Charge - A meter test charge of \$25 may be assessed if a customer requests the meter be tested and the tests show the meter is not more than two percent (2%) fast, and no charge shall be made if the tests show the meter is more than two percent (2%) fast, pursuant to 807 KAR 5:006, Section 18.
