RULES AND REGULATIONS

1. Bills for services will be rendered monthly, the term "monthly" shall mean the period between consecutive meter readings which shall be taken as nearly as possible, every thirty days.
2. Bills are rendered on or about the 1st day of the month for service furnished during the previous month and are due on that date. Bills not paid by the 12th of the month shall be subject to a 10% penalty on the monthly bill amount.
3. A charge of \$150.00 shall be charged for each new service tap, including saddle and first shutoff value that KYTX Pipeline must furnish and install.
4. A reconnection fee if \$ 20.00 shall be paid before service is restored following disconnection of service for nonpayment of bill.
5. A deposit of \$ 100.00 will be required for new accounts. This will be refunded upon disconnection of services and payment of any balance due for gas services. Otherwise, the deposit will be applied toward the outstanding balance and the remaining, if any will be refunded.
6. For matters not addressed herein, KYTX Pipeline adopt the appellation rules of the Public Service Commission.
