Dear Mr. Thompson:

ARCO Metals Company and Orbit Gas Company entered into a Gas Service Agreement dated July 26, 1984, pursuant to which Orbit makes certain gas available for sale to ARCO.

Paragraph 4.1 of this Agreement provides certain allowances for price changes. On December 3, 1985, the price for your gas was lowered to \$3.15 per dekatherm for the first 10,000 dekatherms purchased and \$3.13 per dekatherm for all volumes in excess of 10,000 dekatherms per month and less than 15,000, and \$3.11 per dekatherm for all gas purchased over 15,000 dekatherms per month.

Effective February 1, 1986, the price for gas delivered to you shall be further reduced to \$3.05 per dekatherm for the first 10,000 dekatherms purchased each month and \$3.03 per dekatherm for all volumes in excess of 10,000 dekatherms per month and less than 15,000. The price for all gas volumes purchased in excess of 15,000 dekatherms per month shall be \$3.01 per dekatherm.

This agreement may be changed by either party at any time.

All other terms and conditions of the Agreement shall remain in full force and effect, without any change or modification.

The price for all gas volumes purchased in excess of 15,000 dekatherms per month shall be \$3.11 per dekatherm.
