



The Company shall have the right at any time, without liability to the customer, to curtail or to discontinue delivery of gas entirely for any period of time which such curtailment or discontinuance is, in the Company's sole discretion, necessary to protect and assure operation of the Company's system; to comply with any restriction or curtailment as may be imposed by any governmental agency having jurisdiction over the Company; or for any causes due to force majeure; so that the Company may maintain the operating efficiency of its system in a safe and orderly manner.

- C. The Company will require a written transportation contract with its customer(s) with terms to be negotiated.
- D. It shall be the customer's responsibility to make all necessary arrangements, including regulatory approvals, required to deliver gas transported under the tariff to the facilities of the Company.
- E. The company reserves the right to refuse to accept gas that does not meet the Company's quality specification as merchantable quality gas.
- F. The Rules, Regulations and Order of the Public Service Commission and of the County, and the Company's general terms and conditions applicable to industrial sales, shall apply to this Tariff and all contracts thereunder.
- G. There will be no minimum charge and there will be no discount for early payment.
- H. The Company may provide special transportation services in accordance with individual contracts with the customer. A copy of such contract will be filed with the Commission pursuant to 807 KAR 5:011 Section 13.
- I. Balancing shall be accomplished by a credit on amount billed or by additional billings to be rendered and paid in accordance with the following terms:

Transportation Service Rate TS-1

- i. If it shall be determined that, at any time within twelve (12) months after the date of any statement rendered by Orbit that there has been an overcharge (imbalance) in the amount billed for transportation of gas, and a claim, therefore, is made within sixty (60) days from the day of discovery thereof, the overcharge (imbalance) if verified, shall be refunded within thirty (30) days, together with interest at 8% per annum computed for the period beginning sixty (60) days following the date of the statement to the date of refund.
- ii. If it shall be determined that, at any time within twelve (12) months after the date of any statement rendered by Orbit that there has been an undercharge (imbalance) in the amount billed for transportation of gas, Orbit shall submit a statement for such undercharge and the customer, upon verification of the same, shall pay such amount within 30 days, such payment shall not include interest unless the undercharge is due to meter tampering and/or fraud, in which event interest shall be due at 12% per annum.

The flex discount will not be granted that produces transportation rates below the variable costs associated with service to the customers. The company reserves the right to confirm, to its satisfaction, the reasonableness of the represented price and volume. The Company further reserves the right to decline to flex or to flex the degree requested by the customer.

TERMS AND CONDITIONS FOR SERVICE TAP

1. The natural gas to be delivered to Applicant pursuant to this application shall be for the sole and exclusive use of Applicant at the above property and shall in no wise be resold or redelivered by Applicant to any other person.

2. The Company shall install and maintain at its expense, regulator and service shut-off valve which shall be the property of the Company. All other equipment and material required for such service including service line and automatic regulators shall be furnished, installed and maintained in good condition by Applicant at Applicant's expense and shall remain the property of Applicant.

3. Applicant's installation must be installed using materials approved by the Company and tested by the Company before the gas service is turned on. Applicant's gas service line shall be constructed and maintained subject to the requirements of the American Standard Code for Gas Transmission and Distribution Piping Systems (ASAB 31-1.8 1955).

4. If leaks or other hazardous conditions are detected in the service line, the Company shall have the right to discontinue service until such leaks or other hazardous conditions are repaired or remedied by Applicant.

5. Applicant shall pay for gas service each month at the Company's office a rate equal to the residential rate, including monthly minimum charges, in effect for the previous month in the nearest area served by a regulated public utility. Gas metered for non-residential seasonal use shall not be subject to a monthly minimum.

6. Payment for gas service will be due no later than thirty days after billing. Service may be discontinued for non-payment on ten days written notice after due date.

7. Company will make reasonable efforts to insure accurate metering of gas. If a meter is found to be registering low or high by ten percent (10%) or more an estimated adjustment will be made for the current and next preceding billing period.

8. Company shall refuse or discontinue service to an Applicant, after proper notice, for failure to comply with its rules and regulations or state rules and regulations or:
(a) When a dangerous condition is found to exist on Applicant's premises, (b) when Applicant refuses or neglects to provide reasonable access to the premises, or (c) fraudulent or illegal use of service.

9. A reconnection charge of \$35.00 shall be paid before service is restored following disconnection of service.

10. For each meter installed by Company, Applicant will be required to make a deposit in an amount up to 1/6th of the estimated annual bill for gas service through such meter.

11. Applicant agrees that Company has no obligation to maintain a fixed or specific gas pressure or volume from any well or gathering line serving Applicant's property, and the Company will not be liable for any damage arising from loss of pressure or be liable for accidental injuries or damage which may result from any defect or failure to Applicant's service line or regulator.

12. Company will give no less than fifteen days notice to Applicant if Company elects to shut-in the serving well or to discontinue use of the serving gathering line whichever the case may be.

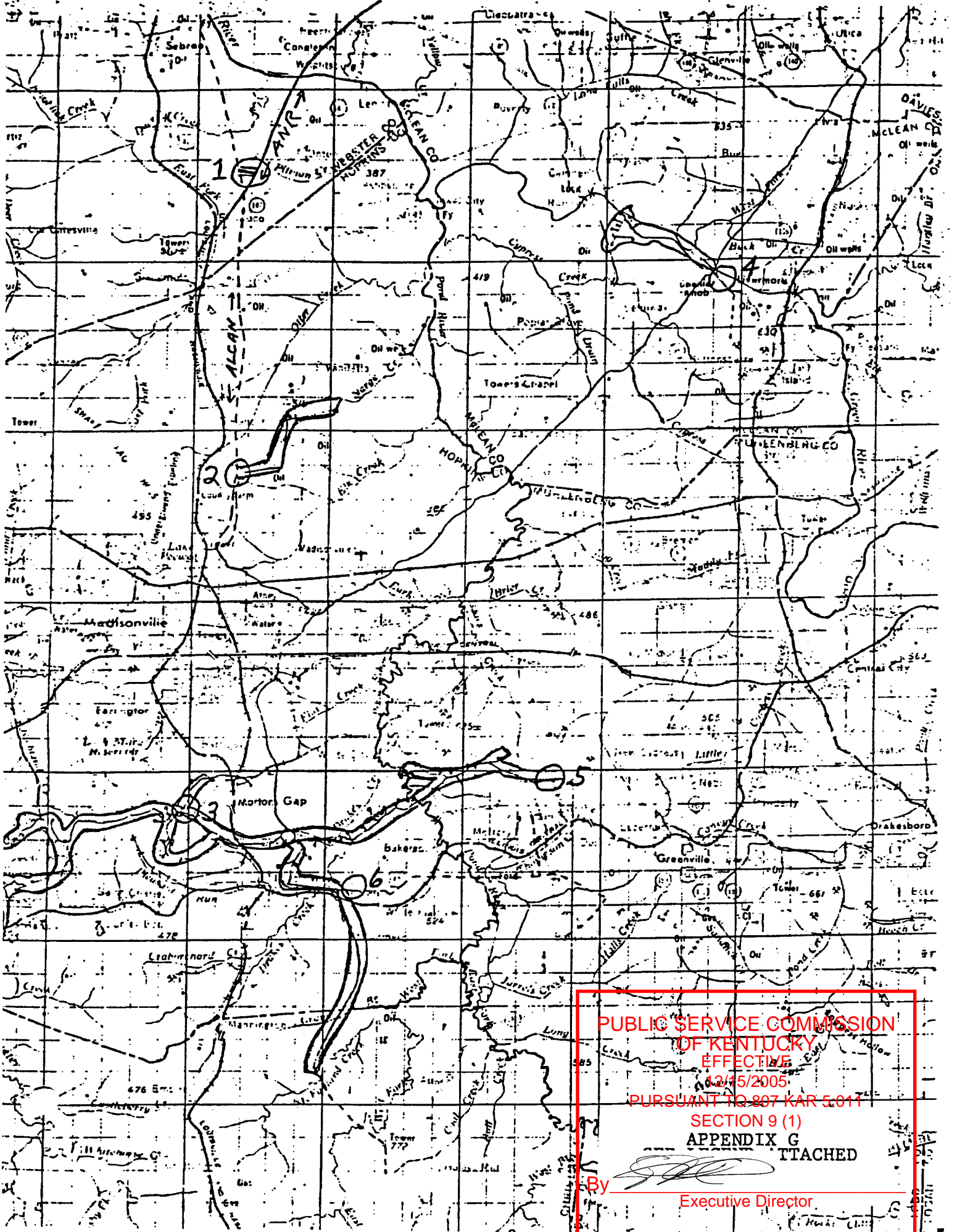
13. Unless otherwise provided herein, the rights and obligations of the parties shall be governed by the provisions of KRS 278.485 now in effect.


