COMMISSION OF THE INTEREST It was a pleasure to meet with you and Mr. Scott in Owensboro on August 31st and discuss problems of mutual interest.

In line with this and past discussions it is evident that the specifications in your present industrial gas contract with us do not cover as closely as they should the requirements of your operations.

Your contract of March 4, 1954 provides for a Daily Contracted Demand of 1,632 Mcf, of which only 25% or 408 Mcf is high priority or firm gas.

On a basis of your latest revised data as submitted to us we understand that your maximum gas requirements in 1956-1957 will be 1,450 Mcf,per day and in 1958 the daily maximum may be increased to 1,750 Mcf.

Your minimum requirements were stated as being 600 Mcf per day to operate two converters and a flare.

Your actual utilization for the year ending July 31, 1956 As we understand was 381, 266 Mcf or a daily average of 1,045 Mcf. your plans, this consumption is to be increased.

The Daily Contracted Demand as specified in the contract should be as nearly in line with the actual requirements as is possible under operating conditions, and for our purposes as well as that of the customer the variation should not exceed 10%. If so, under certain conditions, a revision is in order at the end of each year.

Where any high priority or firm gas is provided for in the contract it is specified on a percentage of the Daily Contracted Demand, as in your case, however, the Daily Contracted Demand is expected to be within reasonable limits of the average daily load.

In accordance with the foregoing and our discussion with you of August 31st we are agreeable to revising your contract of March 4, 1954 from a Daily Contracted Demand of 1,632 Mcf. with 25% high priority or firm gas to a Daily Contracted Demand of 1,440 Mcf with 50% high priority or firm gas. This revision to be effective on and after November 1, 1956.

It is to be understood and agreed that this revision will not in any way affect any other contractual obligations or provisions of the present contract, and that any revision or change does not necessarily establish a precedent to justify any further changes in the contract.

It will not be necessary to revise the entire contract.

This letter is sent you in duplicate and you will please indicate your approval and acceptance of the revision by having the copy signed and returned to us.

Upon your approval and acceptance this letter will constitute a binding agreement between us and will serve as an integral part of the original contract.
