Clinton County Monthly Service Charge - In addition to the charges determined from the contract rates, each residential customer, and space-heating Clinton County customer of up to 4,000 square feet, must pay a monthly service charge of \$8.00 per each billing month. Each Clinton County commercial customer must pay a monthly service charge of \$35.00 per month and all other customers must pay \$75.00 per month.

Floyd County and Johnson County Monthly Service Charge - In addition to the charges determined from the contract rates, all classes of Floyd County and Johnson County customers must pay a monthly service charge of \$15.00

Clinton County Customers Monthly Surcharge - A monthly surcharge of \$0.24 per Mcf will be added to all customer bills effective July 1, 2020 through June 30, 2030. The purpose of the surcharge is to pass on increased wholesale gas costs authorized by the federal Energy Regulatory Commission in Docket No. PR17-54-000. The surcharge was approved by the Kentucky Public Service Commission in Case No. 2019-00430.

Refund to Johnson County Gas and B&H Gas Customers Pursuant to Case No. 2020-00396 - The following refunds shall be paid by Navitas KY NG as denoted in the April 27, 2021 Order in Case No. 2020-00396.

Refund to Johnson County Customers - In Case No. 2020-00122, the KY Commission found that Johnson County Gas ("JCG") owed its customers a refund. Pursuant to the April 27, 2021, Order in Case No. 2020-00396, whereby Navitas KY NG has acquired the JCG systems, Navitas KY NG shall refund to its Johnson County customers \$9,450. This refund shall be issued over a period of 36 months to its customers, which will result in repayment of \$1.00 per customer, per month for 36 months.

Refund to Floyd Customers - In Case No 2015-00367, the KY Commission found that B&H Gas ("B&H") owed its' customers a refund. Pursuant to the April 27, 2021, Order in Case 2020-00396, whereby Navitas KY NG has acquired the B&H systems, Navitas KY NG shall refund to its Floyd County customers \$101,876. This refund shall be issued over a period of 60 months to its customers, which will result in repayment of \$6.80 per customer, per month, for 60 months.

Monthly Surcharge - A monthly surcharge of \$1.00 per MCF will be added to the bills of all Navitas KY system customers, except for former B&H Gas Company customers, until the balances by system are recovered. The purpose of the surcharge is to complete previously approved, but not recovered, Gas Cost Adjustment, Actual Adjustment and Balance Adjustment balances; plus to recognize the GCA balances created during the transition period associated with the acquisition of Johnson County Gas Company and the B&H Gas Company pursuant to Case No. 2020-00396. As ordered, these balances were filed in Case No. 2021-00381 and at that time were \$135,880.45, \$5,763.60, and \$2,133.22 for Navitas KY NG, former B&H Gas Company customers and former Johnson County Gas Customers, respectively. Implementation of these findings by the Commission were ordered in Case No. 2022-00109. The \$1.00 monthly surcharge will no longer be charged to former B&H Gas Company customers as the full residual amount has been recovered from those customers.
